

**ORDINANCE NO. 654
(AS AMENDED THROUGH 654.21)
AN ORDINANCE OF THE COUNTY OF RIVERSIDE
ESTABLISHING A FEE SCHEDULE FOR SERVICES RENDERED
BY THE OFFICE OF THE TREASURER-TAX COLLECTOR**

The Board of Supervisors of the County of Riverside ordains as follows:

Section 1. PURPOSE. The purpose of this ordinance is to establish a schedule of fees, otherwise authorized by law, in the amount reasonably necessary to recover the cost incurred by the County Treasurer-Tax Collector on behalf of the County in providing the products or services enumerated herein.

Section 2. AUTHORITY. The fees established herein are authorized by Government Code Sections 6157, 50077(b), 54985, 54986, 66010 et seq., 66016, and 66451.2, and Revenue and Taxation Code Sections 162, 2188.8(g), 2509.1, 2511.1, 2706, 2922, 2922(e), 3698.5, 3704.7, 4807, 4102, 4112, 4143(f)(1), 4217, 4672.1, 4672.2, 4672.3(a), 4674, 4837.5, 4837.5(i) and 5832.

Section 3. FEE SCHEDULE. The Treasurer-Tax Collector will hereafter collect the following fees for the products or services provided:
