AN ORDINANCE OF THE COUNTY OF RIVERSIDE
AMENDING ORDINANCE NO. 860 RELATED TO ESTABLISHING A SCHEDULE OF FEES
FOR THE ISSUANCE OF WARRANTS AND SERVICES BY THE RIVERSIDE COUNTY
AUDITOR-CONTROLLER

The Board of Supervisors of the County of Riverside ordains as follows:
